Open forum.

Questions were raised about the ownership of a grass verge outside 14 The Hawthorns. This had been maintained by a householder for many years although not in their ownership. Further enquiries to be made by the J Wardell (RWLO) on behalf of Council and a response provided. Reported the springfields hedge is overgrown and a hazard to pedestrians. TC to action remedial works.

Stalbridge Footpath 39 access to/from Robin Way. No progress with DC Rangers in achieving a more accessible access.

Stalbridge Footpath 1 (Grosvenor Rd to Wood Lane): Investigation in relation to report of a possible electric fence alongside the path. Investigation indicates that there is sufficient width, even if the seasonal growth disguises the width available. Wire tested; not live. Further investigation ongoing. The Trailway and connecting bridleways (74 & 75) are awaiting work to improve the surface with 106 funds, very slow progress.

Enhanced SLA Path vegetation cutting still outstanding by DC Rangers.

Green spaces vergeboards which have appeared in green spaces and along verges. In the Nature Reserve orchids have been seen

<u>ACTION</u>: Clerk instructed to write to DC Rangers to expedite action on Footpath 39 access to/from Robin Way and trailway surface improvements with section 106 funds.
